Within WP2 Development of curricula and Activity 2.2 - Defined goals, competencies and learning outcomes of bachelor and master curricula, Atila Bezdan from the University of Novi Sad presented two presentations about Defined goals, competencies and learning outcomes of improved bachelor and master curricula and new master curricula. He has been speaking about suggestions on how to improve existing subjects on the Bachelor's level of study and create new ones on the Master level. In the next session, within Activity 2.3 – Established new and improved existing subjects of the bachelor programme, Jugoslav Brujić, Emira Hukić, Ratko Ristić, Atila Bezdan, and Slobodan Milutinović presented an overview of existing bachelor and master programme at the Faculties from Faculties of Forestry in Banja Luka, Sarajevo, Belgrade, and Niš. They concluded there are no compatible subjects in the field of



soil erosion and flood protection within curriculums in the faculties in Niš, Banja Luka, and Sarajevo.

In the next session, Marijana Kapović – Solomon, Emira Hukić, Ratko Ristić, Atila Bezdán, and Slobodan Milutinović have the presentation of existing subject syllabuses in the field of soil erosion and torrential flood prevention; Proposal for new and improved subjects on existing bachelor and master programmes at the faculties of forestry. All presenters emphasize the importance of improving existing subjects and creating new ones that regard soil erosion and flood protection.

The last presentation, within Activity 2.4 – Established a new master programme, The curriculum of the new master program: structure proposal has been presented by Atila Bezdán.
