The first presentation was about a short report of the Project Coordinator where Nada Dragović presented planned and realized activities that have been realized so far. The next presentations were presented by Mirjana Todosijević and Tijana Vulević regarding the Financial aspect of the project and information about reporting and correspondence. Mirjana Todosijevic spoke about the amount of money that has been spent so far and showed how much each institution spent. Tijana Vulević presented day to day correspondence reports and repeated basic information about reporting ways (internal and formal).

The next presentation was report of the 1st Quality Assurance Committee meeting held on October 2nd, 2019 in Reggio Calabria, Italy, by Paolo Porto. Twenty-two participants from 8 partner institutions attended the meeting that took place at the University Mediterranea of Reggio Calabria, Faculty of Architecture. In the conclusion he stated that the quality control





of the project will be applied during the project by two types of assessments: SELF ASSESSMENT (a procedure that involves the WP leaders and the Partner Institutions leaders) and EXTERNAL ASSESSMENT (by 1(2) external referee(s), nominated by the UB after a selection procedure).

The next presentation was presented by Aleksandar Baumgertel regarded to web-site established and procurement procedures. He has shown problems connected with procurement procedures which the project faced with and some rules for procurement procedures in the Republic of Serbia.

The last presentation about the action plan for the next six months was presented by Nada Dragović where has been shown activities and planned meetings within the next six months.

Conclusions

The conclusion is that the **2**nd **Steering Committee Meeting** of the SETOF project was successfully realized.
