
In November and December 2020, project activities were reduced due to the emergency situation caused by COVID19. During that period, there were several attempts to speed up the accreditation process of the master's program.


At the beginning of December 2020, a notification was received that the Technical implementation report for the SETOF project was qualified as "GOOD".






• 3rd Meeting of the Partner Countries Universities organized by the University of Belgrade (Faculty of Forestry) on the 28th of January 2021.







 At the meeting, the progress of activities WP3 (New bachelor subjects implemented, New master programme implemented and Evaluation of syllabi) and activities of WP5 (Trainings plan defined and adopted, Promotion trainings with engineers in enterprises and Trainings in local communities) was discussed. Also, the preparation of the monography Prevention and management of soil erosion and torrential floods was presented by Prof. Slobodan Milutinović.
