

Short report of the Project Coordinator

Prof. Nada Dragović



After realization of PMU and SC meeting in November 2019, we started to prepare documents for accreditation of joint master programme "Soil erosion and torrential flood prevention".

Univeristies from Serbia and Bosnia and Herzegovina are involved in preparation of master structure and syllabi of subjects (obligatory and elective) for the new joint master's study.

Due to the impossibility of accreditation of the program in Bosnia and Herzegovina, the documentation for accreditation of the joint master's program is submitted by three universities in Serbia (UB, UNS, UNI) as program holders with the participation of professors from the university of Bosnia and Herzegovina (UBL, UNSA) as partner organizations.





- According to the Instructions for accreditation of study programs by National Entity for Accreditation and Quality Assurance in Higher Education - (Standard 13) and recommendations by Rectorate of UB joint study programm is accepted as a form of a new master programme.
- A necessary part of the documentation for accreditation is the Agreement on the
 Development and Implementation of the Joint Master Study Program, which was developed
 and signed by legal representatives from the following universities: UB, UNS, UNI, UNSA, UBL.



- Meeting of the Partner Countries Universities was held at the Faculty of Forestry, UB on 24th January 2020. At the meeting, Report of established new and improved subjects on existing bachelor and master programmes at the Universities of Serbia and BIH was presented by universities from these countries.
- The structure and syllabi of the new master program were presented to. After the discussion, the structure of the joint master program was adopted.













 Preparation of the draft version of Agreement on the Development and Implementation of the Joint Master Study Program takes longer and was presented at the 2th meeting of partner countries universities at the Faculty of Agriculture in Novi Sad.



2nd Meeting of the Partner Countries Universities within a SETOF Project was held at the Faculty of Agriculture, University of Novi Sad on the 12th March 2020.

The accreditation procedure was discussed at the meeting and especially the Agreement on the development and implementation of a joint master's program.

The UB project coordinator presented the standards for accreditation and obligations of all partners participating in the master program.

The syllabi of the subjects of joint master program were adopted at this meeting.













- After that, the activities were stopped due to the state of emergency in Serbia and other project partner countries, so the joint master program could not be adopted at universities. Also, we prolonged collecting of other documentation for accreditation the program.
- The study visit was planned to be held at the Forest Research Institute at the Bulgarian Academy of Sciences (FRI-BAS) and at the Faculty of Forestry University of Forestry in Sofia in March 2020. This study visit could not be done in the planned time because there was an emergency situation in the project partner countries due to COVID-19.







- PMU meeting, SC meeting and QAC meeting were planned for the end of May but could not be realized due to COVID19.
- Following the lifting of the state of emergency in Serbia and the weakening of the pandemic in June, project activities have intensified again.
- All project partners made a great effort during Jun and July to conduct planned activities from WP3 and WP4, especially the leaders of WPs who cretaed Reports.





- The joint master's program was adopted by the Senat of the University of Belgrade and University of Niš on July, 2020, and its adoption at University of Novi Sad is pending.
- The Agreement on the Development and Implementation of the Joint Master Study Program was finally signed by legal representatives on 24th July 2020.
- The documentation for the accreditation of the joint master's program was submitted to the National Entity for Accreditation and Quality Assurance in Higher Education of Serbia on July 27, 2020.



- Many project partners were unable to submit supporting documentation for the financial report, as well as reports on the implementation of planned activities due to the emergency situation (coronavirus), so the project coordinator asked the EACEA to extend the deadline for submission of interim reports. The approved deadline for submitting Interim reports was August 15, 2020.
- Interim report required extensive documentation Financial report, Table of achieved / planned results, and many textual parts that have to be fullfil.
- Interim report was submitted on August 4th 2020.
