Prof. Nada Dragović, coordinator of the SETOF project, and Dragan Savić, director of the enterprise Vodoprivreda d.o.o, Požarevac opened the meeting and welcome participants.

The meeting covered several topics: joint master study program, soil erosion, and prevention of torrential floods in Serbia, the experience of European countries in the prevention of floods, and experience of engineers in the prevention of torrential floods in enterprise Vodoprivreda, doo Požarevac (WP5 Dissemination of project results, Activity 5.5. promotion trainings with engineers in enterprises).

Prof. Nada Dragović gave the overview of the SETOF project objectives, content (work packages), main deliverables, and information regarding the joint master study program including the list of obligatory and elective subjects and teachers from two or more universities engaged in the development of the syllabuses and conducting teaching activities. Tijana Vulević, the Assistant professor, provides some inside into soil erosion and torrential floods problem and prevention in Serbia.

MSc Natalija Momirović gave a history of experience of European countries in the prevention of torrential floods, including Bulgaria, Northern Macedonia, Italy, and Austria.

Luka Matović and Nemanja Trujić, the engineers employed at the enterprises Vodoprivreda doo, presented the enterprise activities and experience in the prevention of torrential floods.



The member of the SETOF project and employed at the Vodoprivreda enterprise discussed the previous works on erosion and torrential flood prevention, good and bad examples of the constructed objects, and future activities.
